Now, JKSSB vide their letter No. SSB/Secy/Sel/2021/7046-53 dated 14.10.2021 has forwarded the select list/ recommendation(s) of the

candidates for the post of Depot Assistant, Food, Civil Supplies & Consumer Affairs Department to the indenting Department i.e. D/oDMRRR.

Further, the details of the selection(s)/withheld recommendation(s) category wise received from JKSSB vide letter No.SSB/Secy/Sel/2021/7046-53 dated 14.10.2021 are enclosed.

Since, the appointing Department/Authority is Food, Civil Supplies & Consumer Affairs Department and therefore, in terms of Govt. Order No.528-JK (GAD) of 2021 dated 21.06.2021, these select list/recommendation(s) of the candidates for the post of Depot Assistant, Food, Civil Supplies & Consumer Affairs Department are being forwarded for appointment and thereof verification of Character & Antecedents at your end. The terms and conditions laid down in the Govt. Order No.528-JK (GAD) of 2021 dated 21.06.2021 are reproduced as under:-

***"The appointing authorities, on the receipt of attestation forms from the candidates, shall forward these forms with a covering letter (sealed and marked secret) in the form prescribed to this Government Order directly to the CID Headquarter for conducting the verification of the Character and Antecedents of the selectees.***

***The CID shall conduct the verification of the character and Antecedents of the selectees and forward the same to the requisitioning authority within one month from the date of receipt some candidates requires more time, the CID may seek another one month in respect of such candidates only while forwarding the completed cases. However, the entire time period in the verification process should not be more than two months under any circumstances.***

***The appointing authority, on the receipt of the satisfactory verification report, issue the appointment order and the candidates in whose case the report is received at a later stage (after the part selection list is operated upon) shall on the receipt of a satisfactory verification report be appointed notionally from the date the earlier appointments are made.***


***In case of receipt of an adverse report and on confirmation thereof by the State/Divisional /District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice."***

Beside above, the appointing authority shall also take the following reference(s) into consideration:-

1. Cognizance of Govt. Order No.586-JK (GAD) of 2021 dated 07.07.2021 who states that S.O.194 of dated 17.06.2020 shall also be applicable to all migrant employees appointed after 17th June, 2020 under the Hon'ble Prime Minister's Special Package.
2. Govt. Order No. 1003-JK (GAD) of 2021 dated 27.09.2021 regarding amendments in the Jammu and Kashmir Civil Services (Verification of Character and Antecedents).
3. Verification of Migrant / Category/Domicile status from the competent authority.

2. Pursuant to the aforesaid advertisement notification, the Jammu & Kashmir Services Selection Board (JK SSB), conducted Computer Based Objective Test for selection of candidates to the posts of District Cadre posts of Depot Assistant item No. 26,27,28,29,30,31,32,33,34 & 35. Based on the performance of the candidates in the said Computer Based Objective Test, the result / score sheet was notified vide Notice No. SSB/Secy/Sel/2021/3556-64 dated 22.04.2021.

3. Subsequently, the candidates figuring in the consideration zone were called for Document Verification in a phased manner. In the meanwhile, the Board after due consideration deemed it expedient to seek preferences from the candidates for different advertised posts, so as to avoid repetition of same candidate in different selection lists.

4. A Selection Committee for preparing the selection list in accordance with the laid down norms and procedures was constituted vide Order No:- 280/SSB of 2021 dated 31-07-2021.

5. Having regard to the above position, the Selection Committee prepared the Provisional Selection List for the post of , which was notified vide No. SSB/Secy/Sel/2021/6761-71, Dated. 05-10-2021 District Cadre posts of Depot Assistant item No. 26,27,28,29,30,31,32,33,34 & 35.2021. In response to the aforementioned provisional Selection List, representations were received by JKSSB which were examined by the Selection Committee. The representations were considered by the Board in its 189<sup>th</sup> Board meeting held on 13.10.2021 and disposed of in accordance with the rules. In addition, the Final Selection List so prepared by the Selection Committee was considered and approved by the Board in the aforesaid Board meeting for publication and forwarding to the concerned Indenting Department.

6. While preparing the Final Select List for the posts District Cadre posts of Depot Assistant item No. 26,27,28,29,30,31,32,33,34 & 35 due to non-availability of candidates in the respective reserved categories, the following posts have been de-reserved to fill all the advertised posts in accordance with the provisions of Government Order No. 10-DMRRR of 2019 dated: 06.03.2019 issued by the Department of Disaster Management, Relief, Rehabilitation & Reconstruction ;and



8. Further, the Selections List/ Waiting List notified shall be subject to the outcome of writ petition (s) (if any) pending for disposal before any court of jurisdiction related to the selection of advertised posts.

9. The document verification / scrutiny conducted by the Board is limited to the extent of physical possession of category /degree, and establishing genuineness /validity or otherwise of the same shall be responsibility of the indenting department / appointing authority. It is important to add that during phase 1<sup>st</sup> of the Document verification due to steep surge in COVID-19 cases, lockdown restrictions and the need to adhere to social distancing norms and health considerations, the original documents could not be checked and candidates were called to upload the same on the link provided by the JKSSB.
