Whereas, a departmental promotion committee meeting was held on28/ 29-12-2011 to consider the promotion of officials of different grades including Class-IV;

Whereas, promotion order was issued vide No.04-DCAPDK of 2012 dated 11-04-2012 in favour of Class-IV officials;

Whereas, the Class-IV officials promoted were placed in the down grade of ₹4440-7440 + GP ₹1400/- against the vacant posts carrying pay scale of ₹5200-20200 + GP ₹1900/-;

Whereas, another DPC meeting was held on 04-02-2013 wherein the officials promoted vide order No.04-DCAPDK of 2012 dated 11-04-2012 were placed in the grade of ₹5200-20200 + GP ₹1900/- against their own posts w.e.f. 28-12-2011;

Whereas, Mrs. Shahina Akhtar made representation to this office wherein she stated that in the DPC held on 28-12-2011 she was figuring at S.No.117 in the prospective list of candidates and due for promotion as per the available vacancy but ignored alongwith other candidates, instead cleared by the next DPC held on 04-02-2013, which marred her seniority by all purposes and requested that the promotion granted in her favour w.e.f. 04-02-2013 be effected from 28-12-2011 in view of availability of posts;

Whereas, the case was placed before the sub committee constituted vide order No.243-DCAPDK of 2013 dated 24-08-2013 read with order No.666-DCAPDK of 2015 dated 17-03-2015. The sub committee met on 09-11-2015 and examined the cases and in the instant case it was recommended to prepare a list of Class-IV prospective candidates who were due for promotion in the DPC held on 28-12-2011 other than the Class-IV candidates who already stand promoted pursuant to decision of the said DPC;

Whereas, pursuant to the recommendations of the sub committee, an exercise has been carried out by the Department and the officials depicted in the Annexure - A to this notification are notified to be prospective candidates for the DPC held on 28-12-2011 other than the Class-IV officials considered/promoted by the said DPC;

Now, therefore, before decision is taken in respect of officials detailed in Annexure-A for granting retrospective effect to their promotion w.e.f. 28-12-2011, objections are invited from the concerned/interested officials, if any, within a period of fifteen days. No objection after expiry of stipulated period-shall be entertained.
