Government Order No 128 -CAPD of 2015

Sanction is hereby accorded to the notification of criteria for identification of priority and non priority households under NFSA:-


INCLUSION

1. Present AAY and BPL list.
2. Households having meager monthly income (certificate from Competent Authority).
3. Houseless and landless.
4. Widows, Orphans, Destitute; militancy and violence affected families in low income group, leprosy patients and domestic house maids.
5. Weaker sections, nomadic families.
6. Old Age Pension holders, specially abled/physically handicapped.
7. Inhabitants having Kuchha houses.
8. Displaced families (Natural Calamity).
9. Labourers and Workers.
10. Slum Dwellers.
11. Any other deserving families identified by competent authority not included above.

EXCLUSION

1. Businessmen having business turnover of Rs. 25 lacs per year.
2. Income tax payees of the slab @ 30% or highest tax slab.
3. Persons having land holding above 80 Kanals in case of individuals and 250 Kanals in case of joint family (based on self declaration).
4. All Gazetted Officers or equivalent rank in Corporations, Boards, PSUs etc.
5. All persons holding Constitutional authority/positions.

All the persons, who are not included in either of the above criteria groups, will be included in Non priority category.

The above mentioned criteria is indicative and not exhaustive. The concerned Deputy Commissioners shall devise strategy / mechanism for identification to cover all eligible families (bonafide state subjects only) as per the target given to each District from deserving and marginalized sections of society as it will be their personal responsibility.


