Whereas, vide Govt. Order No. 10-CAPD of 2016 dated 28-01-2016 tentative Combined Seniority List of Chief Inspectors of Consumer Affairs and Public Distribution Department was circulated for inviting objections, if any, from the concerned to be filled within 21 days from the date of issuance of the said Government Order.

Whereas, within the stipulated period one reference was received from Director, CA&PD, Kashmir with the observation that the post of Chief Inspector is a Division Cadre post, while as not a State Cadre and it was requested that necessary corrigendum should be issued in this regard.

Whereas, the reference received from Director, CA&PD, Kashmir was examined in the Department and it was found that no doubt the post of Chief Inspector is a Division Cadre post, but being the post of Chief Inspector a feeding cadre post/ category for the State Cadre post of Assistant Director, it was felt necessary to merge the separate seniority list maintained by both the Directorates of CAPD , Jammu/Kashmir and issue combined seniority list of Chief Inspectors in order to maintain their seniority in terms of the actual dates from which their services as Chief Inspectors has to be reckoned and facilitate processing and subsequently place their promotion/regularization cases before DPC/PSC.

Now, therefore, the final combined seniority list of Chief Inspectors of CA&PD Department as it stood on 1-01-2016 is hereby issued as per annexure "A" to this order. This shall be subject to final outcome of writ petition(s), if any pending before any Hon'ble Court of Law in this regard.

The date of birth recorded in the seniority list shall not be taken as authentic, but shall be subject to the verification from the service book/matriculation certificate.


