



The above allocation is subject to the fulfillment of following terms and conditions:-

1. The Roller Mill wise allotment to be made by AD's should however be made rationally keeping in view the past performance, capacity and efficiency of each RF Mill after accounting for stocks in each mill so that the release made is executed logically and impartially in order to avoid any complicity or charge of favoritism, in future.
2. The closing balance if any, as on ending 31.12.2015 at sale outlets and Godowns shall be accounted for as availability for the month of January 2016.



3. That the Assistant Directors/TSO shall adhere to the norms laid down for grinding which are vogue and in practice.
4. That the allocated quantity is lifted from the specified loading point within the stipulated time frame.
5. That the ADS shall keep strict vigil and ensure that no pilferage and overcharging at any cost is allowed at the sale outlets.
6. That The ADS shall furnish the information regarding daily lifting and dispatches of foodgrains to the Directorate on the following day without fail.
7. That the operated coupons shall be deposited in the **respective piece checking section** for inspection and records after completion of the distribution of the foodgrains by 5th of the following month
8. That the sale proceeds shall be deposited as per the norms/procedure in vogue after completion of the distribution of foodgrains by 5th of the following month positively.
9. That the un-lifted quantity, if any, owing to failure by any District, shall be correspondingly deducted from the next month's allocation and the un-lifted quantity shall not be re-allotted during the next month.
10. That the entire quantity for a particular centre out of the above allocation due for the month, shall be dumped in one go, against the pre-scheduled roaster in a water-shed form.
11. All codal formalities required under rules should strictly be followed in this regard.
