1. That the allotment of funds should not be construed as an authority / approval for incurring of any expenditure in violation of codal provisions, financial rules and instructions issued by Government from time to time.
2. That the funds are not diverted from one unit of appropriation to another and shall not exceed under any circumstances.
3. That No omission/commission or diversion of funds shall be made under any pretext unless specially and separately is authorised by the competent authority
4. The DDO's will ensure that funds released are utilised strictly in accordance to Finance department No FD-VII-Gen(124)2010 Dated 11.07.2014.
5. That DDO shall complete all codal formalities/ provision before presentation of bill/bills at Treasury.
6. That Treasury officer shall not entertain bill/bills without complete /correct classification under which funds have been released.
7. That Treasury officer shall not allow parking or drawal of funds in the civil deposits without prior concurrence of the Finance Department.
8. That the expenditure shall be made strictly in accordance to the classification under which the funds have been authorised by Finance Department and funds shall be debited to :-
